The Basket of Shares fulfilled the following criteria on 19 February 2014 (i.e. on the trade date) as agreed between the Issuer and its hedging counterpart:

- The "Brand Leaders" selection is based upon the "Best Global Brands 2013" ranking by the branding consultancy firm Interbrand. This ranking is reviewed on an annual basis.

Interbrand's ranking of the 100 most important brands on earth is based on forecasted economic earnings specifically attributable to a brand and an analysis of that brand's strength going forward.

- First selection: It consists of the 50 quoted companies with best brands according to Interbrand's ranking: "Best Global Brand 2013".

- Second selection: only the stocks that are followed by the analysts of Private Banking of BNP Paribas Fortis and with a "Buy" or "Hold" rating are withheld, being 36 shares remaining

- After a last screening based on dividend yield, the 20 shares with the highest dividends are withheld (measured by the sum of Div Yield 2011 and 2012).
