(New General Terms and Conditions initially scheduled for 27 April 2015, but their entry into force has been pushed back to a date still to be determined.)

(Act of 8 December 1992 relating to privacy protection regarding the processing of personal data)

Please note that BNP Paribas Fortis SA/NV (hereinafter "the Bank") is responsible for processing personal data collected through this application.

As a visitor or user of this application, you agree with the registration and processing by the Bank, and its related companies or those of the group to which the Bank belongs, of your personal data: the respect of any applicable legal or regulatory provision, specifically in terms of the prevention of money laundering and the financing of terrorism, management of the contractual and pre-contractual relations, the prevention of abuse and fraud, creation of statistics and tests, staff training, monitoring the quality of the service, commercial prospecting or direct marketing of financial, banking or insurance products as well as other products which are promoted by the Bank, its related companies or those in the group to which the Bank belongs.
